The company combines fuel trading, storage, logistics, and distribution with a growing commitment to cleaner fuels, renewables, and electric mobility.

Operations began at the Sharjah terminal, forming the backbone of the company's distribution network. IPT Energy has since expanded into Dubai Industrial City (DIC) as a strategic hub for local operations, and into Hamriyah Free Zone with a dedicated terminal for trading, storage, and large-scale logistics. These assets position the company as both a physical operator and a structured regional trading platform. A fully owned and managed fleet enhances this infrastructure, ensuring flexibility, operational control, and secure supply across all delivery channels.

Through IPT EV, the company is developing smart electric mobility solutions across the UAE, supporting the country's energy transition objectives.

IPT Energy is a TotalEnergies Marketing Middle East partner and an ELF partner, extending a decades-long strategic collaboration across the region.

With ongoing expansion into Saudi Arabia, Jordan, and Qatar, IPT Energy continues to strengthen its position as a regional leader in integrated, future-focused energy solutions.



IPT Regional Holding – UAE




Storage and Logistics

IPT Energy operates a network of strategically located terminals across the UAE, each designed to optimize specific parts of our energy value chain.

HAMRIYAH TERMINAL, HAMRIYAH FREE ZONE, SHARJAH

Our Hamriyah facility is a dedicated petroleum trading hub with **84,000 CBM** of storage capacity, designed to handle a wide range of petroleum products efficiently and safely. Strategically located with direct access to port infrastructure, it supports import/export operations and bulk product handling across the region.

In addition to serving IPT's own trading activities, the terminal offers third-party storage solutions for partners seeking flexibility, speed, and compliance. Advanced systems for loading, inventory management, and safety monitoring ensure seamless and secure operations.



SAJAA TERMINAL, SHARJAH

Located in Al Sajaa Industrial Area, this terminal is the operational core of IPT Energy's distribution network. It supports large-scale deliveries of 10 PPM diesel, biodiesel, and lubricants to clients across the UAE. The facility enables efficient, high-frequency bulk fueling and direct filling services, backed by a dedicated tanker fleet and advanced fuel management systems. With a focus on service reliability and operational safety, Sajaa plays a critical role in meeting the daily energy needs of key sectors across the Emirates.

DUBAI INDUSTRIAL CITY (DIC) HUB, DUBAI

To strengthen our logistics network and expand national coverage, IPT developed a facility in Dubai Industrial City. Serving as a strategic extension of the main terminal in Saja'a, this hub plays a vital role in enhancing supply chain operations, supporting local deliveries, and enabling rapid response to rising demand for fleet fueling and on-site services. In addition to fuel storage, it includes a fully equipped truck service center for lubricant change, truck wash, and other essential support services for fleet operators. The site also features an operational EV charging zone and integrated solar panel system, reinforcing IPT's commitment to clean mobility and sustainable energy practices.



Together, these terminals form the operational backbone of IPT Energy, delivering reliability, flexibility, and efficiency across the UAE's energy supply chain.

Corporate Services

Fuel distribution remains at the core of our business, backed by a company-owned fleet and strategically located hubs in Sajaa and Dubai Industrial City. We supply high-quality diesel (10 PPM), biodiesel, and ELF lubricants to clients across key sectors, ensuring consistent, compliant, and reliable deliveries throughout the Emirates.

- Our 10-ppm diesel fully complies with the Emirates Authority Standards & Metrology (ESMA) UAE.S 477:202 diesel (Gas Oil) specifications for diesel (Gas Oil).
- IPT Energy holds a Certificate of Conformity issued by the Ministry of Industry and Advanced Technology, confirming compliance with approved national standards.
- We offer flexible delivery solutions designed to meet diverse operational requirements, providing efficient fueling support for businesses across industries.

- Our tankers are approved by Civil Defense and comply with all safety requirements set by UAE authorities.
- Our drivers hold "HAZMAT License" in handling Hazardous Material and "Defensive Driving Certificate" approved by Civil Defense in Dubai.

In 2019, we established a strategic partnership with TotalEnergies Lebanon, resulting in the formation of Fuel Logistics Company SAL, a joint venture managing logistics and annual tenders. Products are transported directly from refineries to IPT Terminal and Lebanon Energy Terminal in Amchit.

Storage


Our two fully equipped terminals in Amchit offer a combined capacity of 50,000 CBM across 24 tanks, meeting international and domestic safety standards.


